

Credit Policy

As the person(s) arranging for this funeral you have accepted several obligations including payment for all burial related expenses. At the conclusion of making funeral arrangements a Statement of Goods and Services will be completed and presented to you for your acceptance. Your signature on the goods and services document indicate that you accept this obligation personally and in any official capacity you might have.

Therefore to avoid any misunderstandings we have adopted the following terms for payment of funeral expenses:

1. At the conclusion of the arrangement conference or prior to performing services, **we require the payment in full of the cash advance items.**
2. A final statement will be sent to you approximately 10 days after the funeral service. The balance is due within 30 days from the date of these arrangements.
3. **Direct cremations must be paid for at the time services are arranged.**
4. After 30 days this account will be charged a late payment fee at the rate of 1.25% per month or 15% per annum on the unpaid balance beginning with today's date. To be fair to all families we serve, we cannot vary from this policy.
5. In the event that arrangements have not been made to pay this account, it will be turned over to legal counsel and pursued by all legal means. Any and all expense related to this will be added to the account.
6. **We reserve the right to request that all funeral expenses be paid in full prior to providing funeral services.**

SERVICES, FACILITIES, AND MOTOR EQUIPMENT

TRANSFER OF REMAINS TO FUNERAL HOME (60 MILE RADIUS; 2.50/MILE) \$525.00

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$2,995.00

Our charge for this service includes the 24-hour availability of our staff, consultation and arrangements with family, clergy, cemetery or crematory and others as required; preparing, filing and securing notices, authorizations and permits; assistance with forms and insurance. *This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.* (This fee is already included in our charges for full service direct cremations, immediate burials and forwarding or receiving remains).

EMBALMING\$ 765.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct. *This service is not required for direct cremation or immediate burial.*

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME \$4,960.00

Our charge for this service includes transfer of remains to funeral home, embalming, basic services of funeral director and staff, dressing, casketing, cosmetics, and motor equipment to point of transportation. *This charge does not include viewing, ceremony, merchandise or shipping charges.*

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$ 3,320.00

Our charge for this service includes basic services of funeral director and staff, and transfer of remains to cemetery or crematory. *This charge does not include viewing, ceremony, graveside service or merchandise.*

DIRECT CREMATION (FULL SERVICE)..... \$3,960.00

Our charge for this service includes transfer of remains to funeral home, basic services of funeral director and staff, sanitizing and dressing of your loved one prior to cremation, private family viewing, memorial/religious package and crematory fees. It does *not* include a service, cremation container, urn or county permit fees.

If you want to arrange a direct cremation, you must use a cremation container. Containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: heavy duty cardboard; plywood container with liner and pillow, variety of wooden caskets.

DIRECT CREMATION (NO SERVICE)\$1,795.00

This service includes our minimum required cremation container, but does *not* include a memorial/religious service, viewing, obituaries and other notices, arrangement conference, or contact with clergy, musicians, veterans' groups, cemeteries, etc.
